Old Business

- **Master Site Plan/Community Park Grove Wish List:** The board discussed a request from Paige to create a new wish list for a Survey Monkey to gauge community interest for the Master Site Plan.
 - The previous survey was conducted approximately seven years ago.
 - The board reviewed previous ideas, including a splash pad, walking trails, and pavilions, and discussed new ideas like a community center, disc golf, and a mountain bike course.
 - The board decided to send a motion to Paige to use the previous survey list, with the addition of any new ideas, to be distributed via Nixle to encourage more community participation. The motion was seconded and approved.
- **Christmas in the Grove:** The board discussed the possibility of holding a Christmas tree decorating event.
 - A member is getting pricing on Christmas trees from BJ's.
 - Ideas were discussed to get community organizations such as the Girl Scouts, Boy Scouts, sports teams, and fire company involved.
 - The board discussed the "Bring Your Own Tree" (BYOT) idea, which would allow participants to supply their own real or fake trees.
 - A motion was made to gather more concrete details, including potential dates and electricity sources, for the next meeting.

New Business

- **Review of Playground Equipment Quotes:** The board reviewed three quotes for playground equipment and focused their discussion on the "Amish made LLC" tractor-themed playset.
 - A main concern was the safety of the tractor playset, specifically the weight limit for the tire swing and the potential for kids to climb on the front lip of the tractor.
