Mr. Schweyer provided an overview presentation to the members of the Recreation Board. Following the presentation, Mr. Schweyer and Ms. Di Biase Dooley answered the questions of the Recreation Board members concerning the specific content of the proposal that was submitted in response to the RFP.

Following the two (2) separate interviews which took place with the above-identified representatives, the Recreation Board members took official action.

ACTION: Motion was made by Robert Cornman and seconded by Roy Bellis to take official action to recommend that the Plainfield Township Board of Supervisors award the Plainfield Township Request for Proposals (RFP) – Plainfield Township Community Park Pavilion Project – NPDES Permit, On-Lot Sewage Disposal System, and Final Construction Professional Engineering Design Consulting Services Professional Services Agreement to Maser Consulting (with USA Architects assigned as the architectural professional services firm) in accordance with the proposal of Maser Consulting (proposal identification number No. 20006689P).

Motion approved. Vote 5-0.
