Bids will be received by the Township from PennBid and publicly read aloud at the Plainfield Township Municipal Building, which is located at 6292 Sullivan Trail, Nazareth, PA 18064, at approximately 3:15 pm the same day. Action is planned to be taken by the Board of Supervisors at a special meeting to be held on Thursday, April 25, 2019 at approximately 7:00 pm at the Plainfield Township Building, 6292 Sullivan Trail, Nazareth, PA 18064. All project documents, specifications and details are available at no cost at PennBid. (www.pennbid.net) Work to be performed under this contract shall include all labor, tools, equipment and materials necessary to construct the Grand Central Road Bridge Replacement including removal and disposal of the existing concrete arch bridge, selective tree removal, stream diversion with turbidity barriers and cofferdams, excavations of all materials, rock excavation, and installation of a new 24' wide x 5' high precast concrete arch bridge system with precast wingwalls as well as restoration of the roadway, surface stabilization and erosion and sedimentation controls required for the work. All bidders are required to attend a mandatory pre-bid meeting to be held on Thursday, March 14, 2019 at 9:00 am prevailing time at the Plainfield Township Building, which is located at 6292 Sullivan Trail, Nazareth, PA 18064. Liquidated damages apply at the rate of \$250.00 per calendar day. Each bidder is required to bid on the total project. The successful bidder shall provide a performance bond or certified check to the municipality in the amount of 100% of the contract and a payment bond or certified check to the municipality in the amount of 100% of the contract within 7 days after the contract is awarded. Work to be performed under this contract shall include all labor, tools, equipment and materials necessary to construct the Grand Central Road Bridge Replacement including removal and disposal of the existing concrete arch bridge, selective tree removal, stream diversion with turbidity barriers and cofferdams, excavations of all materials, rock excavation, and installation of a new 24' wide x 5' high precast concrete arch bridge system with precast wing-walls as well as restoration of the roadway, surface stabilization and erosion and sedimentation controls required for the work.
