PUBLIC NOTICE IS HEREBY GIVEN that the Board of Supervisors of Plainfield Township, Northampton County, Commonwealth of Pennsylvania, at a regular public meeting to be held on Wednesday, January 8, 2020 at 7:00 P.M. at the Plainfield Township Municipal Building located at 6292 Sullivan Trail, Nazareth, PA 18064, will conduct a public hearing on and consider the adoption of the proposed Plainfield Township Official Map and proposed accompanying Official Map Ordinance.

The Board of Supervisors invite public comment on the proposed Official Map and the proposed accompanying Official Map Ordinance, which is only summarized below:

AN ORDINANCE OF THE TOWNSHIP OF PLAINFIELD, NORTHAMPTON COUNTY, PENNSYLVANIA, AMENDING THE CODE OF ORDINANCES OF THE TOWNSHIP OF PLAINFIELD AT CHAPTER 1 (ADMINISTRATION AND GOVERNMENT) TO CREATE A NEW ARTICLE 9 ENTITLED OFFICIAL MAP; ADOPTING AN OFFICIAL MAP OF THE TOWNSHIP PLAINFIELD PURSUANT TO THE MUNICIPALITIES PLANNING CODE OF THE COMMONWEALTH OF PENNSYLVANIA; SEVERABILITY; REPEALER; EFFECTIVE DATE

At the public hearing members of the public will be invited to speak and/or provide written statements regarding the proposed Official Map and accompanying Ordinance for the consideration of the Board of Supervisors. Following the conclusion of the public hearing, the Board of Supervisors will consider both the proposed Official Map and the proposed accompanying Official Map Ordinance for adoption during the Wednesday, January 8, 2020 regular Board of Supervisors meeting. The Board of Supervisors may take official legal legislative action to adopt both the proposed Official Map and the proposed accompanying Official Map Ordinance. All interested parties are invited to attend.
