

**PLAINFIELD TOWNSHIP
INVITATION TO BID**

Sealed bids will be received by the Board of Supervisors of Plainfield Township of Northampton County at the Plainfield Township Municipal Building (6292 Sullivan Trail, Nazareth, PA 18064) until 2:00 PM prevailing time on **Friday, April 3, 2020** for:

Work to be performed under this contract shall include all labor, tools, equipment and materials required for the furnishing, delivery and placement of approximately 56,893 SY of a Double Bituminous Seal Cost using a Polymer Modified Emulsion, CRS-2PM (E-3M) or RS-2PM (E-2M) and #8 Stone with a 1.0% Loss by Wash, 12,233 SY of a Single Bituminous Seal Coat using a Polymer Modified Emulsion, CRS-2PM (E-3M) or RS-2PM (E-2M) and #8 Stone with a 1.0% Loss by Wash followed by a Type II Slurry Seal application in accordance with PennDOT Publication 408 Specification Section 482, and to apply 29,427 linear feet of a double 4" yellow center traffic line with glass beads to roadways. All material to be complete in placed in conformance with current PennDOT Publication 408 Specifications.

Bid documents/specifications may be examined or obtained without charge at the Plainfield Township Municipal Building, which is located at 6292 Sullivan Trail, Nazareth, PA 18064 during normal business hours, 8:00 AM until 4:30 PM, Monday through Friday. Digital copies are also available upon request. Each bid must be accompanied by bid security in the form of certified check, bank cashier's check or bid bond, in required form, amounting to (10%) ten percent of the total base bid made payable to Plainfield Township. All bids must be sealed, clearly marked, "Road Bid Proposal for Letting of April 3, 2020", and be submitted on bid forms supplied by Plainfield Township. All bidders, contractors and subcontractors must be PennDOT pre-qualified in order to bid on this project. Proof of prequalification required with bid submittal. The successful Bidder must provide a Performance Bond in the amount of one-hundred percent (100%) of the total cost of the Contract award and a Payment Bond in the amount of one-hundred percent (100%) of the total cost of the Contract award within twenty (20) days of the award of the Contract.

Bids will be opened and tabulated by the Township Manager or designate at 2:05 PM on April 3, 2020, in the Plainfield Township Meeting Room located at 6292 Sullivan Trail, Nazareth, PA 19064. Consideration for award is anticipated to be at the regular meeting of the Supervisors to be held on Wednesday, April 8, 2020 at 7:00PM at the Plainfield Township Municipal Building, which is located at 6292 Sullivan Trail, Nazareth, PA 19064. Plainfield Township reserves the right to reject any and all bidders, to waive any omissions, errors, mistakes and/or irregularities, and to award the contract in the best interests of the Township.
