The Plainfield Township Board of Supervisors will not be physically present at the Municipal Building for this regular meeting; however, there will be a quorum of the Board of Supervisors participating in the meeting.

During the Thursday, June 25, 2020 Board of Supervisors meeting, Plainfield Township officials will present the Plainfield Township MS4 (Municipal Separate Storm Sewer System) Stormwater Management Program Annual Report. The purpose of this public meeting is to encourage public discussion and participation regarding its stormwater quality and the administration of the MS4 Stormwater Management Program.
