PUBLIC NOTICE IS HEREBY GIVEN that the Board of Supervisors of Plainfield Township, Northampton County, Commonwealth of Pennsylvania, at a regular public meeting to be held on **Thursday, July 23, 2020** will conduct a public hearing on and consider the approval of an Official Map Special Encroachment Permit application involving the following owner(s), parcel(s) and acreage:

The applicant is proposing to construct a single family residential dwelling unit that is located within the reserved public grounds area labeled as “Official Map – Proposed Features – Public Recreational Parking Areas” on the adopted Plainfield Township Official Map.

After reviewing and considering the Official Map Special Encroachment Permit application and proposal that was submitted for this subject property in accordance with Section 405 of the Commonwealth of Pennsylvania Municipalities Planning Code, Article 9 (Official Map), Section § 1-908 (Effect of Official Map and Reservations) (2) (Special Encroachment Permits) of the Code of Ordinances of Plainfield Township, and taking into account any written or oral comment offered at the public hearing, the Plainfield Township Board of Supervisors may proceed, at the conclusion of the public hearing, to approve, approve with conditions, or deny the Special Encroachment Permit application.
